# TMHA Welcomes New Member Lake Michigan Carferry



We are pleased to announce that Lake Michigan Carferry, out of Ludington, Michigan, has become TMHA's newest Allied Member. Representatives of the company attended one of our meetings and were impressed enough to want to become a member.

The S.S. Badger is the last coal-fired passenger steamship in operation in the United States. She has provided a fun, reliable, and affordable shortcut across beautiful Lake Michigan for more than 60 years and has transported millions of passengers since her re-birth in 1992.

The 410 ft. S.S. BADGER can accommodate over-size and super-loads saving time, money, fuel, and permitting by taking a shortcut across Lake Michigan. Loads with dimensions up to 16' 10" wide x 282' long x 18' 6" high, and almost unlimited weight, can be accommodated. There are certain items we can accommodate up to 19' width depending on length. Originally designed to transport primarily railroad cars, the S.S. Badger can handle over 1 million pounds of cargo.

Since 1926, U.S. Highway 10 has been broken into two segments by Lake Michigan between the port cities of Ludington MI, and Manitowoc WI. In July of 2015, The American Association of State Highway and Transportation Officials (AASHTO) notified Lake Michigan Carferry that the route traveled by the Historic S.S. BADGER was being designated as the continuance route of U.S. 10. In 2016 she received the nation's highest historic honor when the Department of Interior officially designated the Badger as a National Historic Landmark. Additionally, the Badger is extremely unique in that she is a non-stationary National Historic Landmark.

From mid-May to mid-October the Badger sails daily between Manitowoc, WI and Ludington, MI. For additional information, call (231) 843-1004 or email trucking@ssbadger.com

# **News from Allied Member XL Specialized Trailers**



XL Specialized Trailers features the Low-Profile Hydraulic Detachable Gooseneck (HDG) trailer in its lineup. While this

trailer can transport a multitude of machines, it is specifically designed to haul paving equipment.



The XL Low-Profile HDG has tapered front beams, offering an extremely low load angle of only four degrees. Additionally, 42-inch flip ramps provide extra loading assistance, making it an ideal solution for the paving industry.

"Operators will be able to load paving machines, rollers and much more with ease," said Tom Hiatt, director of sales at XL Specialized Trailers. "At XL, we pride ourselves on coming up with solutions for customers to help simplify the transportation process, and this is certainly a solution for anyone working with paving equipment, which can be challenging to load onto a trailer."

The 13-foot gooseneck has a swing clearance of 110 inches, and the relief cut out in the gooseneck provides additional space between the truck and trailer. The sloped nose of the gooseneck protects the air and electric connections from damage. The neck also offers a five-position ride height. Based on neck position and load, the deck can be leveled as needed with the adjustable wheel area ride height.

With a capacity of 110,000 pounds in 12 feet, the trailer has an overall length of 53 feet and overall width of 8.5 feet. With Apitong decking for increased durability, the 26-foot-long main deck features a loaded deck height of 24 inches and an 8-inch ground clearance. The trailer also offers a 14-foot-long rear deck that has a 40-inch loaded deck height.

The Low-Profile HDG offers many features from tie-down points to lighting. For starters, the main deck offers seven pairs of bent d-rings along the outer beams, 13 chain drops per side on the outer rails, four chain drops around the toolbox and swing out outriggers on 24-inch centers.

The toolbox, located at the front of the main deck, provides a storage area for chains and other items, while the deep bucket well in the rear provides an area for an excavator bucket to ride safely without detaching the lower boom section.

The standard lighting kit includes a work light in the upper deck to increase visibility when monitoring the load at night.

#### Landstar Awards Matt Miller with Outstanding Management Achievement Award



Matt Miller, Landstar's Vice President of Trailer Management, was honored with the company's Outstanding Management Achievement Award. Traditionally presented

during Landstar's annual agent convention, this year Landstar President and CEO Jim Gattoni surprised Miller with the award during a presentation to independent Landstar agents via a Cisco WebEx ® conference call.

"Matt Miller has played a critical role in developing the digital framework to enhance and automate company-controlled trailer assignment, utilization, tracking and maintenance processes," said Gattoni. "At the beginning of Matt's tenure, many of the trailer processes were manual. As the Landstar trailer count continued to grow, he proactively identified opportunities to build efficiencies to manage the growing fleet."

Since assuming his role in 2015, Miller has led the effort to increase the Landstar trailer fleet from 9,800 trailers to more than 13,000 company-controlled trailers. Under his direction and leadership, Landstar's trailer request process was digitized and includes a trailer yard management system at Landstar's U.S.-Mexico Logistics Center in Laredo, Texas. Most recently, Miller and his staff launched a trailer pool management system, designed and developed in 2020 for independent Landstar agents to provide timely and accurate information on trailer locations and specifications.

The Landstar Outstanding Management Achievement Award honors a Landstar employee who places the successes of Landstar's independent agents and business capacity owners (BCOs)\* above all else. Award candidates are nominated by Landstar senior management based on their effective leadership, managerial skills, contributions to efficiency and productivity, and innovative and practical contributions toward Landstar's mission. Nominees for the award must have at least five years of continuous employment at a managerial level.

\*Business capacity owner (BCO) is the term Landstar uses for independent owner-operators under exclusive lease agreements.

#### Landstar Announces 2021 All-Star Truck Giveaway Finalists

# **TMHA Joins Coalition to fight Nuclear Verdicts**

Recently, your Association joined with many other well-known associations and companies in supporting the "Keep Texas Trucking" coalition. Texas Trucking Association President & Chief Executive Officer, John Esparza, spoke to attendees at this year's TMHA Annual Meeting in San Antonio about the coalition and its goals, among other important issues. The purpose of the coalition was to promote the passage of legislation in the State of Texas that would enact regulations resulting in more fair treatment of defendants involved in litigation in Texas, a state known to be the site of some of what are often known as "nuclear verdicts" against trucking companies.

The legislation was passed by the Texas Legislature and was recently signed into law by Texas Governor Greg Abbott. Of course, the best defense against a large trial verdict is to not have the accident in the first place, but it is hoped the new legislation will provide a fairer and more level playing field when litigation does occur.

# TMHA Joins Coalition to Oppose the PRO Act

Recently, TMHA supported a coalition of interested parties, including other associations and trucking companies, to voice opposition to what is known as the PRO (Protecting the Right to Organize) Act. Below appears a press release from the coalition that offers explanation of the matter and the coalition's goals. The coalition's primary focus is on protecting the independent contractor business model, but the act also contains other provisions that are potentially detrimental to the trucking industry as a whole. # PRESS RELEASE: ORGANIZATIONS SUPPORT CONTINUATION OF INDEPENDENT CONTRACTOR MODEL FOR OWNER-OPERATORS IN TRUCKING

On June 3, 2021, a group of 21 organizations, including trade associations and other interested parties, submitted to U.S. senators a letter voicing their support for continuation of the independent contractor model for owner-operators in trucking. The supporters of the independent contractor owner-operator model include a broad range of carriers, shippers, intermediaries, and small business advocates across industries.

The group unanimously supports independent contractor treatment for small businesspersons who lease equipment with drivers to motor carriers in compliance with federal regulations and established precedent. The letter and accompanying statements point out that the independent contractor model is an entrepreneurial choice and that adoption of the Protecting the Right to Organize (PRO) Act and its provisions adopting a federal "ABC test" for worker classification could have a devastating effect on truckload capacity.

The U.S. House of Representatives narrowly passed the PRO Act (H.R. 842) in a highly partisan vote on March 9. The bill's ABC test is essentially the same as the controversial test for worker classification that is included in California's AB 5 law.
